## TAKOMA PARK MOBILIZATION, INC.

FIRST The undersigned, Victor Thuronyi, whose address is 201 Hodges Lane, Takoma Park, MD 20912, being at least eighteen years of age, does hereby form a nonprofit, nonstock corporation under and by virtue of the General Laws of the State of Maryland authorizing the formation of corporations

SECOND The name of the corporation (hereinafter called the "Corporation") is Takoma Park Mobilization, Inc

THIRD The Corporation is organized exclusively for the promotion of social welfare within the meaning of section 501(c)(4) of the Internal Revenue Code of 1986, as amended (or any corresponding provisions of any future United States Internal Revenue law or regulations thereunder, hereinafter collectively referred to as the Internal Revenue Code), to promote the common good and general welfare of the residents of Takoma Park, Maryland, and the surrounding community

FOURTH In order to carry out the purposes of the Corporation, the Corporation shall have the powers allowed by the General Laws of the State of Maryland, now or hereafter in force, to non-stock corporations

FIFTH The address of the principal office of the Corporation in this state is 8110 Roanoke Avenue, Takoma Park, MD 20912

SIXTH The Resident Agent of the Corporation is Karen Elrich, whose address is 8110 Roanoke Avenue, Takoma Park, MD 20912 The Resident Agent is a citizen of and resides in the State of Maryland

SEVENTH The Corporation is governed by a Board of Directors The initial number of Directors of the Corporation is nine. The number of Directors may be increased or decreased in accordance with the Bylaws of the Corporation but must never be less than three (3). The initial members of the Board of Directors, who serve until their successors are elected and qualify, are as follows. Maurice Belanger, Shayla Davis, Karen Elrich, Sarah Fitzpatrick, James Iwugo, Lisa Seigel, Dan Sisken, Victor Thuronyi, David Ward

EIGHTH The Corporation must adopt bylaws not inconsistent with these Articles, which provide for

- a the number, qualification, election, terms of office, powers, and duties of the Board of Directors,
- b the qualification, rights, and duties of the members of the Corporation (hereinafter members),
- c the selection of officers and their number, terms of office, rights, powers, and duties, and
- d other matters relating to governance of the Corporation

NINTH The following provisions are hereby adopted to limit and regulate the powers of the corporation and the Board of Directors

- a The corporation is not organized for pecuniary profit
- b No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its directors, officers, members or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services actually rendered and to make payments in furtherance of the purposes set forth in article Third
- c The corporation has no authority to issue capital stock, and has no power to declare dividends
- d The corporation shall have members
- e The activities of the Corporation shall not primarily consist in participating in or intervening in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office
- f Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any activity not permitted to be carried on by a Corporation exempt from federal income tax under Section 501(c)(4) of the Internal Revenue Code
- If the Corporation is dissolved or ended for any reason, the Board of Directors shall dispose of all of the net assets of the Corporation exclusively to the City of Takoma Park or to such organization(s) which are organized and operated exclusively for charitable or educational purposes as shall at the time qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code Any remaining assets not disposed of by the Board shall be disposed of by the Court in the jurisdiction in which the principal office of the Corporation is then located, exclusively for such purposes or to such organizations

TENTH The duration and existence of the Corporation shall be perpetual

ELEVENTH The Corporation may indemnify any and all of its current and future directors, officers, employees and agents as provided in the Bylaws of the Corporation
